Road Commissioner's Report

Mark Dara delivered his report to the Board. He informed the Board that pot holes in the Village as are scheduled to be repaired next week. Road sweeping will be conducted after Easter. Mayor Morrow commented on the large pot holes on East Shore Road.

Mr. Dara informed that he and Ms. Devol visited a site on East Shore Road where a guard rail and part of the roadway require repair. Mr. Dara is going to discuss the guard rail with the Town of Huntington.

Village Administrator's Report

Gail Devol delivered her report to the Board.

There are two public hearings before the Zoning Board of Appeals in April.

The snow refunds are ready to return to the road associations.

The 2019-2020 Huntington Bay Assessment Roll is ready. Tax bills will be sent out before May 15, 2019.
